## THE JUDICIARY

REQUIREMENT TO BE ABOVE PARTISAN, REGIONAL, AND  
POLITICAL PRIORITIES

**Mr. Reginald Stackhouse (Scarborough West):** Mr. Speaker, the late Chief Justice John Cartwright once said that the courts should be like the navy—a silent service. There are many reasons for this, but the primary one must be our need for an authority that is above partisan or regional or ideological priorities.

As the late Chief Justice Bora Laskin said of the Supreme Court of Canada: "It is a national institution—just as there is no federal allegiance, there is no regional allegiance and no political allegiance."

Essential to democracy is variance of opinion, but also essential is a court capable of having the last word in disputes because it is never party to disputes. If judicial spokesmen enter the arena of political debate, everyone will lose, but they will lose the most.

**Hon. Chas. L. Caccia (Davenport):** Mr. Speaker, Kevin and Kate Oswald of Kingston wrote to the Minister of the Environment (Mr. McMillan) about Environment Week. They state:

What impact will this campaign have on the 85 chemical contaminants in Lake Ontario, 8 of which are known carcinogens?

On Monday-Tuesday-Wednesday we are to "tune it up"—what? Our cars? From Tuesday to Friday "let's give it up"—what? Smoking? Driving? Detergent? Breathing? ## DESCHÊNES COMMISSION—REFUSAL OF SOVIET INVITATION

**Mr. Bob Pennock (Etobicoke North):** Mr. Speaker, the Deschênes Commission has correctly refused an invitation from the Soviets to collect evidence on alleged Nazi war criminals in Canada.

I have spoken on many occasions, as have several of my colleagues, to warn of the likelihood that the Soviets would

manipulate the proceedings to serve their own political goals. The six safeguards contained in Justice Deschênes' ruling were designed to protect against such manipulation. We now learn that the Soviets fully intended to conduct this investigation entirely under the criminal procedure of the U.S.S.R. Soviet justice is not justice. I am glad to see the Commission recognizes that fact.

## ELIMINATION OF RURAL DELIVERY ROUTES

**Mr. Cyril Keeper (Winnipeg North Centre):** Mr. Speaker, over the weekend we in Winnipeg learned via the media that 10 rural routes were being cut by Canada Post. Until now rural routes have brought the mail home. Now some rural residents will have to travel as far as 15 kilometres away, at a cost of up to \$700 a year, just to get their mail. In some cases
