PRAYERS.

The Honourable Mr. McDonald (C.B.), from the Standing Committee on Miscellaneous Private Bills, to whom was referred the Bill (13) intituled: "An Act respecting the Hamilton Powder Company," reported that they had gone through the said Bill, and had directed him to report the same to the House without any amendment.

THE SPEAKER'S CHAMBERS,

FRIDAY, 25th September, 1896.

The Standing Committee on the Restaurant have the honour to report that in accordance with the Order of Reference made by Your Honourable House on Tuesday, the 15th instant, "That the question of the sale of intoxicating beverages within the precincts of the Senate be referred to the Committee on the Restaurant, to consider and report upon at their earliest convenience," they have taken the same into consideration and submit the following:—

That the Restaurant is necessary for the convenience of His Honour the Speaker

and Members;

That there is no Bar in the common acceptation of the term—merely a small store-

room for wines and other beverages;

That clause 10 of the contract with the Caterer which provides that the Restaurant is to be used only by the Senators and such other persons as have been approved of by the Speaker and the Committee, and excludes from it all other persons, has been substantially complied with, and that the Committee intend to enforce strictly the said tenth clause of the contract;

That the Rule prohibiting the sale of wines and other beverages to any one not a

Member of Parliament will be strictly enforced.

The Committee recommend that no wines or other beverages be served to any one after 12 o'clock midnight and that the Restaurant and Wine Room be closed at that hour.

All which is respectfully submitted.
