his behalf. If this education is not sufficient, render him all the aid possible by recommending him to attend our institution, and pursue his studies, or if necessary by sustaining him there for a time, or otherwise supply him with useful books that the man of God be thoroughly furnished. But let us not commence the work of making ministers ourselves, but rather pray the Lord of the harvest that he would raise up and send forth faithful labourers. We are however encouraged when we look bac on the past, when the man of Sin so mightily prevailed, and the Church of God appeared like Nebuchadnezzars tree, to have been bewn down and destroyed, yet were the stump of the roots thereof left in the earth, even with a band of iron and brass, and being wet with the dew of heavenly grace they budded, sprung forth and bore fruit. Its branches are now spread out over the nations, and we are encouraged by the promise that no weapon formed against Zipn shall prosper, and persevering in the observance of all things whatsoever the Lord has commanded we shall find him a present help, yea he will be with us always, even to the end of the world. a second district and a second

CONSTITUTION OF THE CENTRAL BAPTIST AS-SOCIATION.

ART, 1.—This Association shall be composed of Ministers and other Delegates, who shall be members of the churches which they represent, together with Delegates from corresponding Associations, and such other brether present as the Association shall see fit to invite to air in Council.

ART. 2.—The Association shall meet at such time and place as may be greed upon by the body.

ART. 3.—Each Church shall have the privilege of sending one Delegate or more, but no Church shall be entitled to sead more than five in addition to their Pastor.

ART. 4.—At each meeting of the Association, the Moderator of the preceding year shall call for a vote for a Moderator, which vote shall be given by ballot: no brother shall be chosen Moderator two years in succession. It shall be the duty of the Moderator to preside in all the transactions, nominate Committees unless ordered by the Association, and maintain due order. A Secretary shall be chosen whose duty it shall be to record the transactions of the Association, and to furnish a correct copy of ART. 5th — It shall be the

Aut. 5th.—It shall be the duty of each Church to send by its Messengers a letter to the Association giving an account of its state, particularly of its additions and diminutions, within the last year, and generally of whatsoever relates to its peace and prosperity.
