

Eminence Cardinal Taschereau. Is a public lecturer author of several published literary works, and one of the founders of *La Justice* newspaper. Has been an Alderman of the City of Quebec since 1880, and is a dir. and Vice-Presdt. of the Quebec & Lake St. John Railway Co. Has been Presdt. of Le Club Cartier de Quebec; The Quebec Geographical Soc.; L'Institut Canadien de Quebec and La Société St. Jean Baptiste de Quebec. An unsuccessful candidate for L'Islet in the Commons at g.e., 1882. First returned to Commons by acclamation for present seat, 7 Jan., 1888, to fill vacancy created by death of his brother-in-law, Mr. H. J. J. Duchesnay. A National Conservative.—*Quebec*.

CIMON, SIMON, C.E. (*Charlevoix*.) 2nd Mem.

Eldest s. of the late Simon Xavier Cimon, M.P., who represented Charlevoix in the Commons from 1867 to 1872, and again from 1881 until his death, 26 June, 1887. B. at Murray Bay, 15 Dec., 1852. Ed. at Montmagny Coll., Thom's Academy, Que., and by private tuition. M., 8 Jan., 1884, Amanda, only dau. of the late J. Vincelas Taché, Esq., Sheriff of Kamouraska, P.Q. A C. E., and P.L.S. for Que., and a member of the Canadian Soc. of Civil Engineers. Was on the Grenville Canal Engineers' Staff from 1872 to 1876. Resident Engineer on the Q. M. O. & O. Ry. (now forming part of the C. P. R.), from 1876 to 1879, and from then up to August, 1887, one of the Engineers of the Dept. of Public Works of Can., which position he resigned to become a candidate for present seat. First returned to Commons 28 Sept., 1887, to fill vacancy caused by death of his father. A Conservative.—*Murray Bay, P.Q.*

COCHRANE, EDWARD, J.P. (*East Northumberland*.) 2nd Mem.

S. of James Cochrane, a native of Yorkshire, Eng., by Mary Davis, of Wexford, Irel., who both settled in the Tp. of Cramahe, Ont., in 1826. B. there, 1 Jan., 1834. Ed. at Colborne, Ont. M., 1st, 5 Aug., 1856. Miss Mary Hicks (she d. 3 July, 1872); 2ndly, 26 April, 1876, Ellen Louisa, dau. of Stephen Thorn, Esq. Is a farmer. Has filled all municipal positions in the Tp. of Cramahe, and was Warden of the United Counties of Northumberland and Durham in 1880. First returned to Parlt. at g.e., 1882. An unsuccessful candidate at last g.e. The sitting mem., Dr. Mallory, being unseated for bribery by agents, a new election was held 22 Dec., 1887, when Mr. Cochrane was
