

Of the *Ottawa Agricultural Insurance Company*; praying for the passing of an Act granting them power to wind up their affairs.

Of the Honorable *John Sutherland*, and others, of the City of *Winnipeg*; praying to be incorporated as "The *St. John's Bridge Company*."

Of the *Canada Landed Credit Company*; praying for the passing of an Act enabling them to lend money upon real estate in *Manitoba* or the *North-West Territories*, or any Province that may be formed out of the same; at such rate of interest as may be agreed upon.

Of the *British America Assurance Company*; praying for the passing of an Act to consolidate and amend their several Acts of Incorporation.

Of the Right Reverend *John*, Lord Bishop of *Saskatchewan*, and others, Clergy and Laity of the Church of *England*; praying to be incorporated as "The Synod of "the Diocese of *Saskatchewan*."

Of *John Mather*, and others, of the Dominion of *Canada*; praying to be incorporated as "The *Rainy River Improvement Company*."

Of *J. S. Kennedy*, and others, of the City of *Winnipeg*; praying for the passing of an Act to amend the Act incorporating "The Chartered Bank of *London and North America*."

Of *John S. Newberry*, and others; praying to be incorporated as "The *Sault Ste. Marie Bridge Company*."

Of "The *Napierville Junction Railway and Quarry Company*"; praying for the passing of an Act to amend their Act of Incorporation.

Of *F. S. Haynes*, M.D., and others, of the Counties of *Missisquoi, Iberville and St. Johns*, in the Province of *Quebec*; praying to be incorporated as "The *Richelieu Bridge Company*."

Of *J. H. Long*, and others, of the County and Province of *Ontario*; praying to be incorporated as "The *North-Western Bank*."

Of the *Portage, Westbourne, and North-Western Railway Company*; praying for the passing of an Act declaring it a work for the general advantage of *Canada*, empowering them to build a line of Railway into the *North-West Territory*, with branches south of their main line, to construct and work a Telegraph line, acquire and work steam and other vessels, to acquire land by purchases from the Government for the benefit of the Company; also to have additional power to issue bonds and preferential stock; to declare certain Acts passed by the Legislature of the Province of *Manitoba* special Acts within the meaning of the "Railway Act, 1879," and to give the Company power to amalgamate with other Railways.

Of the Trust and Loan Company of *Canada*; praying for the passing of an Act authorizing them to do business throughout the whole Dominion, to agree with borrowers on rate of interest to be charged, and to issue debenture stock.

Of "The Mutual Life Association of *Canada*;" praying for the passing of an Act to change their name to "The Life Association of *Canada*," and for other purposes.

And of *Matthew Gardiner*, late of the Township of *Sydenham*, in the County of *Grey*, and Province of *Ontario*, now of *Rapid City*, in the Province of *Manitoba*; praying for the passing of an Act to dissolve his marriage with *Elizabeth Ann Gardiner*, and find that the provisions of Rule seventy-two of this House have been complied with in this case.
