2. Petition for power to the Municipality of the Township of Sarnia to acquire the land covered by the waters of the said Lake, in consideration of their draining the same, (1859) 123. Bill presented, 221. R. A., 590. (22 Vic. [2nd Sess.], c. 77.)

Passed, 239. *Not returned from the Council.*—Order of leave read ; Bill again presented, (1865, Aug. Sess.) 17. R. A., 273. (29 Vic., c. 40.)
3. Petition for an Act to compel occupants of land in U. Canada to destroy the Thistles growing thereon ; Nichol Municipality, (1863, Feb. Sess.) 26.
4. Petition for authority to County Councils to pass By-laws for preventing the growth of Weeds ; Lambton Mun. Council, (1863, Feb. Sess.) 44.
