PRAYERS.

Mr. Doherty moved, seconded by Mr. Pelletier, That this House do, on To-morrow, resolve itself into a Committee of the Whole to consider a certain proposed Resolution respecting the salary of the Registrar of the Supreme Court of Canada.

Mr. Doherty, a Member of the King's Privy Council, then acquainted the House, That His Excellency the Administrator, having been informed of the subject matter of this Motion, recommends it to the consideration of the House.

Resolved, That this House will, To-morrow resolve itself into the said Committee.

On motion of Mr. Currie, seconded by Mr. Sexsmith,

Resolved, That this House doth concur in the Second Report of the Joint Committee of both Houses on the Printing of Parliament.

Mr. Currie, from the Joint Committee of both Houses on the Printing of Parliament, presented to the House the Third Report of the said Committee, which is as follows:—

The Committee carefully examined the following documents and recommend that they be printed:—

**124.** Return to an Address to His Royal Highness the Governor General of the 10th February, 1913, for a copy of the Memorial presented to the Government during the Session of 1911-12 by a delegation from the Government of Prince Edward Island, asking for an increased Provincial Subsidy, a copy of which Memorial was laid on the Table of the House by the Finance Minister last Session of Parliament, but is not now apparently on the files of the House.

**154.** Return to an Order of the House of the 27th January, 1912, showing the amount of the subsidy paid to each of the four original Provinces of the Dominion at Confederation, and the population on which such payment was based; the Subsidy payable to each of the remaining five Provinces on entering the Union, and the population on which such payment was based, the sum added to the subsidy of any Province as better terms, and the date when such addition was made, respectively; the details of each re-adjustment of Subsidies since 1867, and the yearly subsidy at present payable to each Province, with the population on which such payment is based, and the original debt allowance, if any, respectively, placed to the credit of each Province on entering the Union.

**170.** Return to an Order of the House of the 3rd March, 1913, for a copy of the Contract passed on the 6th day of August, 1910, between the City of Quebec and the Transcontinental Railway Commissioners, for the acquisition by the latter of the property known as Champlain Market, to be used as a station and terminals for the said Railways; of all the correspondence between the said city and the present Commissioners of the said Railway, with the Minister of Railways, or any other Minister, with regard to the non-execution of the said contract by the said Commission.

**190.** Copy of correspondence respecting the Treaty of Commerce and Navigation between the United Kingdom and Japan.

**191.** Copy of the Order in Council in connection with the appointment of a Commission to enquire into the claims of the Province of British Columbia for exceptional treatment.
