(i) The letters patent appointing said commissioners shall confer upon them the power of summoning witnesses before them and of requiring such witnesses to give evidence on oath orally or in writing, or in solemn affirma-tion (if they are persons entitled to affirm in civil matters) and to produce such documents and things as the commissioners may deem requi-site to the full investigation of the matters into which they are appointed to inquire and the commissioners shall have the same power and authority to enforce the attendance of witnesses and to compel them to give evidence as is vested in the Supreme Court of the Northwest Territories in civil cases.
