### BARBARA ANN SCOTT

WINNER OF EUROPEAN, OLYMPIC AND WORLD  
WOMEN'S FIGURE SKATING CHAMPIONSHIPS

Mr. J. T. RICHARD (Ottawa East): Mr. Speaker, I think it is only fair that before I put my question to the Prime Minister I

should pay particular tribute to a lovely lady from Ottawa who has become the queen of the skating world, Barbara Ann Scott. As the member for an Ottawa seat, the one in which the Minto skating club is located; and also as the owner of the first pair of fancy skates worn by Barbara Ann Scott. I am proud indeed to pay tribute to the fairest lady of this country. My question to the Prime Minister is whether any suggestions have been made to him with regard to the tribute to be paid to Barbara Ann.

Right Hon. W. L. MACKENZIE KING (Prime Minister): Mr. Speaker, when Miss Barbara Ann Scott won the European championship and the Olympic championship I sent her a telegram on behalf of the government and people. Yesterday I sent another one to her, this time on the winning of the world championship. Hon. members would, I am sure, wish it to appear on *Hansard*. It is as follows:

Dear Barbara Ann: All Canada is prouder of you than ever. Once more warmest congratulations upon winning for the second time the world championship in figure-skating contests. Your triumph is shared by all your fellow-Canadians who now await your return to accord you a truly national welcome. I extend these congratulations on behalf of the government as well as on behalf of the people of Canada. In the world arena of sports you have indeed brought high honour to our country and to yourself.
