\*DISCIPLINARY MEASURES FOR RETURNING OFFICERS

# Question No. 1,346-Mr. Ricard:

1. Has the returning officer, during his term of office, the right to ask for funds for the benefit of a political party?

2. If not, are disciplinary measures provided and what are they?

Mr. Albert Béchard (Parliamentary Secretary to Secretary of State): Mr. Speaker, this question, in my view, appears to ask basically for an interpretation of the provisions of the Canada Elections Act. It is my understanding that ministers of the crown cannot properly offer such legal interpretations; thus I do not feel that I can rightfully attempt to answer this question by the hon. member in its present form.

#### TOILET FACILITIES ON PUBLIC WHARVES, NOVA SCOTIA

#### Question No. 1,371-Mr. Coates:

1. On what public wharves in Nova Scotia has the federal government installed toilet facilities? 2. What is the annual revenue available to the federal government for the installation of toilet facilities on public wharves in Nova Scotia and which of the wharves make payments and in what amount in each case?

3. From whom are the revenues received in each case?

Mr. J. A. Byrne (Parliamentary Secretary to Minister of Transport): 1. Caribou, Pictou, Sydney and Yarmouth.

2 and 3. Public toilet facilities are installed at the Caribou and Yarmouth ferry wharves. At Pictou, small office and toilet facilities installed in wharf shed for Magdalen Islands Transportation Company Limited under lease, annual rental \$690. At Sydney a portion of the wharf shed, including toilet facilities, is occupied by Robin Hood Flour Mills Limited under lease, annual rental \$8,400.
