CBC COVERAGE, 1968 LIBERAL CONVENTION

Question No. 443-Mr. Broadbent:

- 1. For the Liberal Convention held in Ottawa in April 1968, what was the total coverage given to the convention by CBC (a) English radio and television (b) French radio and television?
- 2. What sessions of the Liberal Convention were broadcast "live" by the CBC radio and television and what was the total time of such coverage?

Hon. Gérard Pelletier (Secretary of State): I am informed by the Canadian Broadcasting Corporation as follows: Since this convention was a leadership contest, extensive coverage was given on CBC English and French radio and television networks. Combined total radio and TV coverage which included live coverage of speeches, voting for leadership candidates etc., amounted to approximately 43 hours on the English networks and 24 hours on the French networks. Of these amounts approximately 31 hours on the English networks and 19 hours on the French networks were devoted to live coverage from the floor of the convention.

- 1. For the New Democratic Convention held in Winnipeg in October, 1969, what was the total coverage given to the convention by CBC (a) English radio and television (b) French radio and televi-
- 2. What sessions of the New Democratic Party Convention were broadcast "live" by the CBC radio and television and what was the total time of such coverage?

Gérard Pelletier (Secretary of State): I am informed by the CBC as follows: The combined total radio and TV coverage of this biennial convention amounted to approximately three hours on the English networks and 13 hours on the French networks. While there were numerous actuality clips used during the period of the convention, the only live coverage in full from the floor was the hourlong closing address of T. C. Douglas on the English networks.

Gérard Pelletier (Secretary of State): I am informed by the Canadian Broadcasting Corporation as follows: Since this convention was a leadership contest, extensive coverage was given on CBC English and French radio and television networks. Combined total radio and TV coverage which included live coverage of speeches, voting for leadership candidates, etc., amounted to approximately 48 hours on the English networks and 20 hours on the French networks. Of these amounts approximately 40 hours on the English networks and 17 hours on the French networks were devoted to live coverage from the floor of the convention.

NORTHUMBERLAND STRAIT CROSSING
