control that could be effective and that we should undertake. There are areas of assistance to people who are badly hurt by the cost of living in which we can take effective action. We should take those steps. Further, there are areas of control of Canadian resources in which we should act to protect the future independence of this country. I am not sure how my hon. friends to my right, physically and politically, will act when we return on October 15. I do not know whether they will continue to be the paper tiger they have been since last January, threatening to bring the government down, but not taking the opportunity to do so when it is presented to them.

I can tell you, Mr. Speaker, so far as my colleagues and I are concerned, that we declared our policy at the beginning of the session. In fact, we declared it last November before we knew exactly which party might be the government. We meant that policy, and we intend to pursue it. I hope that when we get back on October 15 this parliament will continue to be productive in the interests of the people of Canada, and as long as it is productive in those interests this parliament, so far as we are concerned, is doing a job of work which ought to be supported.

Mr. Reid: On a point of order, Mr. Speaker, on Wednesday last the hon. member for Cape Breton-East Richmond (Mr. MacInnis) raised a point of order concerning the adequacy of an answer provided to him by the Department of Regional Economic Expansion. On investigation, I found that that point of order was indeed well founded. I now have a revised answer. I would ask the permission of the House to present it to the House now, and to have it printed in Hansard as a proper response to the hon. member's question.

Mr. Deputy Speaker: I think the suggestion is probably a reasonable one, because if the parliamentary secretary had to wait until we passed the adjournment motion then the hon member for Cape Breton-East Richmond (Mr. MacInnis) might not get his answer until October 15. Is it the pleasure of the House to accept the suggestion of the parliamentary secretary?

Mr. Stanfield: Yes, Mr. Speaker, without any commitment that we agree it is a satisfactory answer.

Mr. Deputy Speaker: The suggestion of the parliamentary secretary is accepted.
