### HOUSING

### MORTGAGE INTEREST RATES—GOVERNMENT ACTION TO REDUCE AND INCREASE NUMBER OF STARTS

Mr. John Gilbert (Broadview): My question is directed to the Minister of State for Urban Affairs. The banks increased their mortgage lending rates last week, which will have a serious effect on the housing market this year. In view of the fact that the minister and his officials have contacted bank officials regarding the effects of the increase, will the minister report the results of his consultations and assure the House that the banks will roll back the rate increase?

Hon. Barney Danson (Minister of State for Urban Affairs): Mr. Speaker, I certainly cannot give the hon. member such an assurance. Discussions with lenders, builders and client groups is a regular process on my part and the part of my officials. We are watching the situation very carefully and doing everything possible to make certain that a stable mortgage market exists and that housing is available for Canadians.

Mr. Gilbert: Peter Carter, the assistant general manager of the Royal Bank, in a speech yesterday said that mortgage interest rates are probably at their lowest level right now and that they will rise sharply during the year. He estimated there would be about 180,000 starts this year. What does the minister intend to do with regard to controlling interest rates and increasing housing starts?

Mr. Danson: I do not control interest rates. We respond to the money markets as they are, and we make it possible for Canadians to buy housing. We are trying to do that and to find rental accommodation under extremely difficult circumstances and in an uncertain economic climate, but I can assure the hon. member that, in a situation which might be relatively short-term in its consequences, I will not panic by introducing long-term measures.

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, in answer to the second part of the question, the Minister of Industry, Trade of Commerce is a valuable minister who contributes greatly to the strength and stability of the Canadian economy.

On the first part of the question, because there is some difference of opinion and some uncertainty, we have appointed a royal commission to investigate the general subject.
