## DOT-UNINSURED LOSSES

## Question No. 2,967-Mr. Clarke:

- 1. With reference to the uninsured losses of more than \$1,000 of equipment recorded by the Department of Transport in footnote No. 20 at page 13.4, volume 1 of the 1979-80 Public Accounts of Canada, under what circumstances were the barrel buoys and anchors lost and (a) who was culpable (b) were any convictions made and, if so, what sentences were imposed (c) are any trials or appeals pending (d) was the equipment replaced (e) did the Department undertake steps to ensure that such a loss does not recur and, if so, what were they?
  - 2. What use does the department make of the barrel buoys?

Mr. Jesse P. Flis (Parliamentary Secretary to Minister of Transport): 1. The loss of the barrel buoys and anchors was attributable to bad weather (storms, strong winds, and ice) and the normal wear and tear of such material. (a), (b) and (c) Not applicable. (d) Yes. (e) A recovery procedure is in effect for material such as chains, counterweights, and sinkers, whereby a Coast Guard vessel equipped to locate such material is dispatched to the locations of the losses when the amount of material involved is sufficient to justify the recovery effort. In 1978, chains, sinkers and counterweights at a value of \$81,000 were recovered.

## Order Paper Questions

2. The buoys assure navigational security and prevent loss of life and material. The buoys also protect the marine environment from pollution by petroleum products which could result if ships strayed from the main channel.

#### HEALTH AND SOCIAL SERVICES PROGRAM

## Ouestion No. 2.979-Mr. Clarke:

With reference to the professional and special services recorded by the Department of National Health and Welfare under the Health and Social Services Program at page 32.23, volume II of the 1979-80 Public Accounts of Canada, with particular reference to motion picture production and distribution (a) what was the title and total cost of each film produced in the fiscal year 1979-80 (b) at what audience was each film aimed (c) what cost recovery is anticipated from the distribution of all the films?

# Mr. Doug Frith (Parliamentary Secretary to Minister of National Health and Welfare):

- (a) The department contributed towards the cost of production of the following films and film program:

  Health and Welfare Contribution
  - Challenge for Change \$100,000

A series of films depicting Canadian society produced by the National Film Board under a program administered by a committee of seven departments and the National Film Board and funded through annual departmental assessment with an equal amount being provided by the National Film Board.

2. Rehabilitation Film 49,049

A film was created within the context of the International Year of Disabled Persons for the purpose of increasing the awareness of the general public towards the problem of integration of the handicapped.

3. Adoption Film

\$ 26,111

A film created to give an understanding of the current adoption situation in Canada, by explaining changes, by outlining the role and responsibility of agencies, and by examining the background and attitudes of adopting couples. The production cost was shared with seven provinces.

The Department also contributed \$60,878 to the National Film Board, towards the cost of creating a captioning centre capable of responding to the needs of the hearing impaired, in both official languages. The program deals with feature films and other films of current interest and the cost includes the purchase of films for captioning purposes.

A further \$63,657 was expended for booking promotional films on nutrition and drug information and a series on child abuse.

(b) With the exception of the Captioned Film Program, which is specifically directed toward the hearing impaired, all films are directed toward the general public and professional groups and include such topics as nutrition, alcohol, tobacco and drug abuse, rehabilitation of the handicapped and child adoption.
