investor gets the tax credit, and the broker gets a fee. No research and development is performed and the country gets ripped off. Will the Minister change the system to create a refundable tax credit which will be refundable to the company doing the R and D work, if in fact the work is done, and paid by the Government to the company if it has no taxable income?

Hon. Marc Lalonde (Minister of Finance): Mr. Speaker, there are so many questions like this. I will take this as representation for the content of the next Budget.

MEASURE TO AMEND

Mr. Dan McKenzie (Winnipeg-Assiniboine) moved for leave to introduce Bill C-246, an Act to amend the Canadian Human Rights Act (official languages).

Mr. Speaker: Is it the pleasure of the House that the Hon. Member shall have leave to introduce the Bill?

Some Hon. Members: Agreed.

He said: Mr. Speaker, this Bill calls for the insertion of the word "language" as a ground of discrimination in the Canadian Human Rights Act. At the present time English-speaking Canadians, including 70 ethnic groups in Canada, are being denied employment and promotion because of severe language proficiency tests. These individuals have no method of filing a complaint because the word "language" is not in the Canadian Human Rights Act. The word "language" is in the United Nations Charter and it is also in the Quebec Human Rights Act. It should be inserted into the Canadian Human Rights Act. It has been recommended by the retiring Language Commissioner, Mr. Max Yalden, that the word "language" be inserted into the Act.
