PRESENTATION OF REPORT OF SEVENTY-SEVENTH INTERPARLIAMENTARY CONFERENCE

Mr. Benno Friesen (Surrey—White Rock—North Delta): Mr. Speaker, pursuant to Standing Order 101, I have the honour to present to the House the report of the official parliamentary delegation which represented Canada at the Seventy-seventh Interparliamentary Conference in Mango, Nicaragua on April 27 to May 2, 1987, in both official languages.

CANADA POST—OPPOSITION TO CORPORATE PLAN

Mr. Nelson A. Riis (Kamloops—Shuswap): Mr. Speaker, I have the honour to present a stack of petitions from residents of Falkland, Avola, Lions Bay, Sorrento, and Monte Creek, British Columbia.

They are concerned about the proposal of the federal Government to seek financial self-sufficiency by 1990 for the Canada Post Corporation and believe that it will result in cutbacks, in deterioration of service in the Post Office, and consequently will be at the expense of service to Canadian consumers, particularly those in rural areas.

They also believe that proposed measures have already resulted in the closure of many rural post offices and the cancellation of routes in rural communities, which will mean a drastic reduction in services in these small communities.

Therefore, they call upon the Government to make improved service the highest priority for Canada Post and to instruct the Government to abandon the policy of closing rural post offices and cancelling rural postal routes.

RIGHT TO LIFE OF THE UNBORN—LEGISLATIVE PROTECTION
