**NORTH TORONTO.**—Townpeople Object to Lack of Attention Shown by the Company.

**NORTH TORONTO, Oct. 29.**—Of late patrons of the Metropolitan Railway are registering many complaints regarding the local service. They assert that the system as applied to North Toronto is fast going from bad to worse. It is hardly local service.

Running on a time table during rush hours and passengers who are required to be at their work at certain times to be frequently late, while high school pupils are kept waiting for the C.P.R. train.

That the outgoing council prepare the estimates for the following year on the assessment completed by the commissioner. That the new council revise the estimates and strike the tax rate. That the new council in-  
crease of 20 cents to be payable in instalments, January 1st, 1st, no discount to be allowed on first instalment, but a surcharge of one per cent. on second instalment when paid with first instalment; payment of taxes at bank branches; assessment of taxes to be replaced by deputy to be responsible for collections; assessment rolls to be delivered to him no later than April 30 of year following preparation. At present the rolls are held open too long.

In collecting arrears of taxes, the auditors say:  
"Under the present system, it is comparatively easy for a ratepayer, who has the ear of a collector, to remain in arrears for a longer or shorter period, with considerable gain to himself and loss to the public, and this will be the case as long as the present system obtains."

To take advantage of the privilege of paying amounts of less than \$10 without interest, the new council should show up the accounts with vouchers in the treasurer's department. This report was brought out in the parks department.

Such expenditures as luncheons (to Longboat, for instance, \$292), are declared to be unnecessary.

**In the Works Department.**  
Regarding the works department, a purchasing agent is necessary. The entire works department could be rearranged and reorganized with great advantage to the city's work. In 1907 \$16,000 was expended for extra expert services in the engineering department.

Regarding the waterworks accounts the auditors say:  
"We think it desirable that in compiling the annual statement of the revenue derived from the waterworks (which appears in the treasurer's statements), as close an approximation as possible to commercial methods of valuing the water be obtained. The capital expenditures being separated from ordinary operating expenses. The meter system is suggested, based on Cleveland's success."

The auditors take exception to the use of sinking fund investments for other purposes, bonds being sold and the proceeds passed to the credit of the city's general account.

"Altho, in all cases, these moneys have been replaced, with the necessary interest, 'we take strong exception to this use of funds, which should be, and in our opinion are, trust funds,' they say."

There should be a more rigid censorship on the expenditure of appropriations as made by the council, to see that the amounts so appropriated are not exceeded. It appears to us, from the number of accounts that are over-run, that the matter does not present itself to the executive officers as we deem it a serious character as we deem it. On the question of unexpended balances, a habit has grown up of carrying forward balances to the credit of accounts, where the appropriations have not been exhausted, or against possible outstanding accounts. We are of the opinion that this practice is incorrect. The meter system is suggested, based on Cleveland's success."

The auditors take exception to the use of sinking fund investments for other purposes, bonds being sold and the proceeds passed to the credit of the city's general account.
