environmental assessment of the Dempster link in an acceptable form before September 1 of this year?

Hon. Roméo LeBlanc (Minister of Fisheries and the Environment): Mr. Speaker, in fact the environmental assessment panel under Dr. Hill was given the mandate to include the Dempster link in its terms of reference. I expect its interim report—and I underline the word "interim"—before August 1, or on August 1. As I said in the statement which I made when the panel was set up, this initial report will be followed by a more thorough examination and details could be added to what would be environmental clearance if and when this is required. The panel will not necessarily terminate its work by August 1; it will give an interim report.

# POSSIBILITY OF APPROVING ALCAN ROUTE PRIOR TO ENVIRONMENTAL ASSESSMENT OF DEMPSTER PIPELINE

Mr. Bill Jarvis (Perth-Wilmot): A supplementary question, Mr. Speaker. Even on the basis of an interim report by August 1, is it the minister's position that the government may give a commitment to the Alcan route, an important part of which is the Dempster link, before receipt of an acceptable and thorough environmental assessment review of that link?

Hon. Roméo LeBlanc (Minister of Fisheries and the Environment): Mr. Speaker, I suppose the discussion will be on words like "acceptable". It is obvious that an environmental assessment report will identify the problems. Then, the work of putting in conditions which would overcome the problems could continue even after a decision is made. In other words, a decision can be made if something is "acceptable" on a given number of conditions, and this is the work which would continue.
