The Woodburn Sarven Wheel Co. agree to pay \$30,000 annually in wages. This means that there will be \$30,000 more in circulation in Chatham every year as soon as the factory is running.

Some aldermanic candidates seem to think that the only qualification re-quired is that to be found in the as-sessment rolls and some seem to think that even that isn't necessary.

Only the factory or plant is exempt from taxation, and that only for ten years. It is safe to expect that a large portion—probably more—of the city's share of \$589.55 will be made up by the additional individual taxes paid by the Chaplin people, so that the portion borne by the city becomes nominal.

The free water supply is limited to 3,000 gallons per day. The cost to the city is about 15 cents daily.
