

CUSTOMS TARIFF.
(OFFICIAL.)

Resolved, That it is expedient to prohibit the importation to Canada of all Goods manufactured or produced by prison labour, or which have been made within or in connection with any person, gaol or penitentiary, and to attach a penalty to any such importation.

Books, printed, periodicals and pamphlets, not elsewhere specified, not being foreign reprints of British copyright works, nor blank account books, nor books to be written or drawn upon, nor copy books, nor Bibles, prayer books, psalm and hymn books, fifteen per cent. ad valorem.....	15 p. ct.

Printed, lithographed, or copper, or steel plate bill-heads, cheques, envelopes and miniature newspapers, receipts, drafts, cards, other commercial blank forms, and other printed matter not elsewhere specified, thirty per cent. ad valorem.....	30 p. ct.
Coloured labels for fruit, vegetables, meat, fish, confectionery, and other goods, also tickets, posters, advertising bills and folders, a specific duty of 15 cents per pound and twenty-five per cent. ad valorem.....	15 cts. and 25 p. ct.
Maps and charts, twenty per cent. ad valorem.....	20 p. ct.
Newspapers partly printed and intended to be completed in Canada, twenty-five per cent. ad valorem.....	25 p. ct.
Printed music, bound or in sheets, ten cents per lb.....	10c. p. lb.
Valentines, Christmas and New Year's chromo or embossed cards, and all others not being business or advertising cards, twenty-five per cent. ad valorem.....	25 p. ct.
Labels for fruit, vegetables, meat, fish and confectionery, and other goods, also tickets, posters, advertising bills and folders, ten cents per pound, and twenty per cent. ad valorem.....	10 cts. p. lb. and 20 p. ct.
Leather board, three cents per pound.....	3c. p. lb.
Boot and shoe counters, made from leather board, half a cent per pair.....	½c. p. pr.
Paper hangings, or wall paper in rolls, the following specific duties on each roll of eight yards and under, and so in proportion for all greater lengths of the following descriptions, viz :	
a. Brown blanks, 2 c. b. White papers, grounded papers and satins, 3c. c. Single print bronzes, 7c. d. Coloured bronzes, 9c. e. Embossed bronzes, 11c. f. Coloured borders, narrow, 8c. g. Colored borders, wide, 10c. h. Bronze borders, narrow, 15c. i. Bronze borders, wide, 18c. j. Embossed borders, 20c.
