**Correspondence.**

Newcastle, June 5th, 1897.  
 TO THE EDITOR.—The letters in your  
 issue of May 26, signed "Progress" and  
 that in your issue of June 2nd signed  
 "Cash" deserve some notice. I shall deal  
 with the last first, Cash should study  
 some and become enlightened on what  
 makes property. He will not be sure  
 find out that low or falling prices means  
 business stagnation, and our town is not  
 now and in fact never did suffer very  
 much from the want of business stagna-  
 tion. A little thought and action may  
 do Cash some good.

The letter of "Progress" is of such a  
 virulent and envious character that one  
 is forced to the conclusion that it is the  
 emanation of a most malignant mind,  
 and was dictated by the gall-dripping pen  
 of a disappointed failure. The comparing  
 of men who have succeeded in legitimate  
 business to "Vampires" is the strongest  
 proof that "Progress" has not a full  
 appreciation of the "Golden Rule." He  
 asks—"Where are the fortunes accumulated  
 by those who formerly did business on  
 our river?" It is none of his business  
 where they are. As this question has a  
 communistic flavor, I will go a little  
 further and add, that there are some few  
 cases settled and settled right too—in  
 this world and one is that "A man  
 may do with his own as he pleases,  
 provided that in the doing he does not  
 injure others," again, all are agreed that  
 happiness is the aim of life, and happiness  
 being a condition of the mind it follows  
 that if a man thinks he is going to add  
 to his happiness by building "Saloon  
 Retreats" or by migrating to other  
 countries with his lawful accumulation,  
 he has not only a natural but a legal  
 right to do so, and is the duty of  
 society to protect him in the full enjoy-  
 ment of those rights. This idea is  
 susceptible of individual interpretation,  
 but enough has been said to stimulate  
 "Progress" to thought and action and  
 thereby evolve to that place where he will  
 have a just appreciation of the rights of  
 others.

**Dominion Parliament.**

(Continued from first page)  
 OTTAWA, Ont., June 2.—The first  
 order in the commons today was con-  
 currence in the senate's jubilee address.  
 Hon. Mr. Laurier moved the resolu-  
 tion in a brief and neat address, com-  
 paring her majesty's reign with that of  
 Louis XIV. of France. This might not  
 have been quite as long if the speaker  
 had been distinguished by scientific discovery,  
 while in the application of such discovery  
 to the affairs of life, no reign in history  
 was comparable to the present one.  
 Queen Victoria was a model to her por-  
 trait and richest subjects in those virtues  
 which were ornaments of domestic life,  
 and model to all monarchies in her  
 conduct as queen. Canadians paid this  
 tribute not as sycophants but as loyal and  
 self-respecting subjects.

Sir Charles Tupper in seconding the  
 resolution, paid a generous tribute to  
 Mr. Laurier by expressing his pleasure  
 that the address was to be laid at the  
 foot of the throne by one so well worthy  
 to represent Canada. He spoke of the  
 high character of the imperial court  
 in the present reign, and said that her  
 majesty, though in every sense a con-  
 stitutional ruler, had through her  
 capacity and sagacity in public affairs  
 exercised a potent and beneficent in-  
 fluence on the history of the country.  
 The Queen had seen Canada united.  
 Sir Charles hoped she might live to see  
 a united Australia and united South  
 Africa joining hands to increase the  
 power of the empire. The prayer for  
 her majesty's long life would be uttered  
 not only by all parts of the empire, but  
 by every good man and good woman in  
 the world.

After the adoption of the address the  
 members sang to their feet and sang  
 God Save the Queen, in which the crowd  
 in the galleries joined.  
 The house went into committee on  
 the tariff, taking up the combined clause.  
 Sir Charles moved an amendment, to  
 the effect that while the house is pre-  
 pared to support a stringent measure for  
 preventing combinations to unduly  
 enhance the prices, such legislation  
 should not be included in a tariff bill,  
 thus exposing the industries to govern-  
 ment interference without the judgment  
 of a superior court of law.

Sir Charles wanted to make the  
 discussion as short as possible, and  
 briefly summed up his objections. He  
 exposed the industries to coercion by  
 the ministers, while it authorized a  
 quasi judicial influence. This would  
 not be the same as the process of law.

because the government initiated the  
 proceedings and fixed the penalties; had  
 the power to discriminate and to punish  
 without really saving their friends.  
 Lastly the government by abolishing the  
 duty on articles subject to combine,  
 would punish the producers who were  
 not in the combine at all, and though  
 innocent, would suffer with the guilty.  
 No Mr. Fielding claimed there was  
 no other way than this to meet the  
 difficulty. Combines were the result  
 of protection. This government had not  
 been able to abolish protection, but  
 desired to prevent one of its effects.  
 However, he did not think there would  
 be any action on the clause. It was  
 to prevent combines, and thus their pun-  
 ishment would be called for.

Hon. Mr. Cassin objected to the  
 clause. It would give the government  
 a chance to investigate the private  
 business affairs of any manufacturer  
 against whom any person may make a  
 charge. It would call judges into the  
 matter not really judicial, and would  
 lead to all manner of accusation of  
 partiality against the judges.  
 Mr. Britton of Kingston, a government  
 supporter, disapproved of the  
 process by which innocent men would  
 be punished. He proposed a second  
 amendment, which, he hoped, the  
 government would accept, that when  
 the duties were abolished under the  
 act the government should make com-  
 pensation to innocent persons in the  
 same business.

The discussion was continued by  
 Craig and Davies.  
 Hon. Mr. Foster asked Hon. Mr.  
 Davies whether in case a judge reported  
 that a combine existed the government  
 would have discretion to act or remain  
 passive.  
 Hon. Mr. Davies said there would be  
 full discretion.

 by Messrs. Fowler, Wallace, Dupont,

 occasions in defence of the proposition.  
 After midnight, Hon. Mr. Foster  
 suggested that the committee rise.  
 The government refused, being determined

 Mr. Davis then took the floor, speak-  
 ing amid constant interruptions and  
 the throwing of missiles for more than  
 an hour. He remarked that if he could  
 not get a hearing he would hold the  
 floor till midnight next day. Before  
 one o'clock, Sir Richard yielded with  
 as good grace as possible and the committee  
 rose.

**CUBAN AFFAIRS.**

MATANZAS, Cuba, June 7.—Wendell  
 Phillips, the Irish republican leader of  
 the London Chronicle, was with several  
 other newspaper men released from pri-  
 son at Matanzas yesterday, where he had  
 been confined ten days, on condition  
 that he will leave Cuba and never return.  
 Phillips avoided Spanish censorship by  
 sending his letter to the Chronicle  
 through the British consul at Havana.  
 During his trial he was defended by  
 British Counsel.  
 NEW YORK, June 7.—A special to the  
 Mail from Havana, Cuba says: "A

**INDIANS ASPHYXIATED.**

CHIEF JULIAN OF THE MICMACS AND HIS  
 BROTHER, THE LATTER EXPERT-  
 ED TO DIE.

A serious, and it is feared in one in-  
 stance, fatal case of asphyxiation, oc-  
 curred yesterday morning in the Rich-  
 mond Hotel. Chief Joseph Julian of the  
 Micmac tribe, Knapewituk, Northern  
 New Brunswick, arrived in the city on  
 Sunday night, accompanied  
 by his brother, C. Joseph Julian.  
 They bore letters of introduction from  
 the Province of New Brunswick, and  
 the Hon. Wilfred Laurier, Premier of the  
 Dominion, and were bound with them  
 for the Capital. They stayed over in  
 Montreal last night and took a room  
 at the Richmond. The brother, who is  
 the elder of the two, retired to bed early  
 leaving gas burning, but the chief did  
 not join him until late. Before  
 retiring to rest the chief blew out the  
 gas and sought his couch.

At ten minutes past ten yesterday  
 morning one of the chamber maids in  
 making the round of the corridors per-  
 ceived a horrible smell, and on entering  
 the room occupied by the Micmacs.  
 She notified the office, and on the door  
 being forced open both men were found  
 lying insensible, the chief on the floor  
 partially under the bed and the brother  
 on the bed. The escape of gas was very  
 strong, and the windows of the room had  
 to be broken to enable the relief party to  
 remain in the place. Dr. Currier was  
 at once sent for, and is still in attendance  
 on the two men. The chief is out of dan-  
 ger, although feeling far from well, but  
 his brother is still unconscious, and  
 account of his advanced age it is not  
 thought likely that he will recover. The  
 chief was awakened, and by the smell  
 of the gas, but fainted on getting  
 out of the bed.—Montreal Witness, June 1st.

**BAIE DE CHALEURS RAILWAY.**

THE ROAD FORMALLY HANDLED OVER TO  
 THE ATLANTIC & LAKE SUPERIOR  
 RAILWAY COMPANY.  
 METABONA, Que., June 1.—At mid-  
 night the Dominion Government official-  
 ly turned the running of trains on the  
 Baie de Chaleurs Railway, which has  
 been operated as a branch of the Inter-  
 colonial since January last, and the road  
 was handed over to the representative  
 of the Atlantic & Lake Superior  
 Company. As the rolling stock lately in  
 use has been withdrawn and that be-  
 longing to the Atlantic & Lake Superior  
 Company is being brought up, the road  
 will probably be closed for a few days.  
 The C. P. Railway will carry the Inter-  
 colonial rolling stock, and the extension  
 of the road is expected to go forward as  
 soon as the company can finance their  
 bonds under their arrangement with the  
 late government of the province.
