Colombo, Ceylon, May 8.—The British ship Earl of Shaftesbury, Capt. Marguarat, which sailed from New York Oct. 3 for Bombay, and arrived in Bombay March 13, has been wrecked in deep water of Amblagodde of the southwestern coast of Ceylon, about 100 miles from Colombo. The captain and five of her crew were drowned.

The House then went into committee on the bill. The Story of the Crime.

When Carlisle W. Harris murdered When Carllsle W. Harris murdered his girl-wife, Helen Potts Harris, if he did nurder her, he committed one of the most remarkable orimes that ever came to light in New York. The trial excited bublic interest and indignation to a great degree. The evidence showed that the crime was the outcome that might have been expected of a life, short as it had been up to then, that had been spent in fast living and intrigues with women. Though Harris was but 29 years old when brought to trial, he openly boasted of these amours and of the case with which he could bring young women under his control.

Before he secretly married Helen Potts, he had already contrasted a clandestine marriage with a young women, because he could not accomplish his purpose otherwise, as he confessed. That union was never acknowledged to the world, though the jury found that it furnished a motive for Harris to want to keep his bigamons marriage with Helen Potts a secret. It was this mctive, with others growing out of additional perplexities that Harris' adventures with women had brought him into, that fastened the crime upon him.

Carlisle W. Harris was born in Glen Falls, N. Y., in September, 1869. His father, though not living with Mrs. Harris, is still alive. With his mother Harris, when only a boy, went to live in Brooklyn whis warmest friendships, as well as the most of his playmate, that even at a very early day his warmest friendships, as well as the most of his playmates, were of the opposite sex. Harris was sent for. He seemed to care little for his wife's death, but feared he would be held responsible. The apparent preparations Harris had made to clear himself of suspicion, and previous remarks he had made about wishing Helen were out of the way, caused suspicion to fail on him. He refused absolutely to allow Helen to be buried as Mrs. Harris. He told many conflicting stories to the mother, who repeated them to the district attorney. The officer presented the facts to the grand jury, who indicted Harris on May 13, 1891. He was arrested and brought to trial on Jan. 14, 1892.

In JOSS That 8 Million

There remains, apparently, but one act in the London and Port Stanley Railroad drama, and that is for the mayor to take proper steps for the conveyance of the \$25,000 forfeit from the Molsons Bank, where it has been held, to the coffers of the city treasury. The climax came this morning and was not unexpected. Since Mr. Zerbe's solicitor, Mr. Rice, left for home after his fruitless efforts to rent the road—and retain the forfeit—for \$6,000 a year, it has been known that the road was on its last legs. The Grand Trunk became clamorous for the rental of the rolling stock, and yesterday served notice on the representatives of the L and P. S. R. to the effect that unless the rent was forthcoming by 1 o'clock this morning the train would not be made up to-day. That they held out very meager hopes of the rent being forthcoming is evident from the fact that they (the G. T. R.) sent its mail car back to St. Thomas by means of the M. C. R. evening train. They also notified the postoffice inspector that some different arrangements would have to be made for sending the mail to St. Thomas. As there is no early morning train on the M. C. R., there was no other recourse but to forward the mail by stags to St. Thomas, to connect there with Canfield Junction. Promptly at 5 o'clock this morning the mails were dispatched by that method, and the 9:50 a.m. train on the M. C. R. found Postoffice Inspector Barker specifing towards the Railroad City to see what further arrangements can be made there. The mails between Port Stanley and St. Thomas will be carried by villagers whose business calls them to the city every day.


