respect to the financial ability of the person, persons, company or corporation who have been promised the subsidy?

Hon. JAMES SUTHERLAND (Minister of Public Works):

1. Yes.

2. On the 18th of May, 1903.

3. Yes, the Vancouver Dry Dock and Shipbuilding Company, Limited. The initiative steps were taken by S. Thompson, the names of the other parties interested are not known to this department.

4. Extract from report of G. A. Keefer, resident engineer, under date of October 8,

1903, as follows:

As to the solvency and responsibility of the Vancouver Dry Dock and Shipbuilding Company, Limited, as a firm, I have no means of knowing further than a favourable personal knowledge of its representative, Mr. S. Thompson. Mr. Thompson is a marine and mechanical ways to be a second of the control of mechanical engineer of high standing, has been a resident of Vancouver for 16 years, and in business for himself for the past five years, and the valuation of his property, plant, &c., in Vancouver is placed at \$100,000. In Vancouver is placed at \$100,000. He is in touch with and known to the firm of Clark & Stanfield and the constructing firm of Clark & Hunter, designers and builders of the Bermuda, Havana, davana, Algiers, Maryland, and numerous other floating docks, of which they make an exclusive specialty, to whom the work of the Vancouver dock will be given. Mr. Thompson's reference and the special sp references are: Evans, Coleman & Evans, Bank of Montreal, Canadian Bank of Commerce, and Molson's Bank, all of Vancouver, so we may assume that his business standing is all right. It is his intention to proceed to England immediately on obtaining the necessary permission to construct from the Dominion government, where he anticipates no trouble in floating the company, as he states the necessary capital has been secured contingent on government assistance and permission being obtained.

MAIL SUBSIDIES-MONTREAL AND BRI-TISH PORTS.

Mr. HENDERSON-by Mr. Sproule-asked:

What was the total amount paid by the government during the year ending 31st December, innent during the year ending 31st December 1993, as mail subsidies and steamship subventions for ocean and mail service, or other steam communication, between the port of Montreel Montreal and any port or ports in Great Britain

Rt. Hon. Sir RICHARD CARTWRIGHT (Minister of Trade and Commerce). I would eall the attention of the hon, gentleman to the fact that almost all the steamship subsidies paid for steamers from Montreal cover a double circuit, from Montreal during the summer, and from Halifax, St. John or other ports during the winter. Consequently, there may be a question of subdividing. With this qualification I would say that the total amount paid was \$110,656.25. will have to be divided hereafter.

PAYMENT OF MILITIA AT VALLEYFELD.

Mr. CLARKE asked:

Have the Valleyfield municipal authorities paid to the government of Canada the sum de-manded for the services of the militia who were called out on the occasion of a strike in Valleyfield?

3. What was the amount demanded by the government; and what was the amount paid by the municipality?

Hon, Sir FREDERICK BORDEN (Minister of Militia and Defence). I beg leave to read a memorandum on this subject, prepared by my deputy:

This case now stands as follows:

On the 10th instant His Excellency in Council approved of the settlement of the case on the basis of an offer by the municipality, viz.: To pay the cost of transport and pay for the first and second day the troops were out.

At the end of the second day (26th October, 1900) seven magistrates had ordered the withdrawal of the troops, and the department is advised that the power which can order the troops out can also order their

withdrawal.

They were not, however, withdrawn on the 26th, as the officer in command thought it inadvisable to do so.

Some of the troops were withdrawn on the 27th and others later, until on the 30th

all had been sent home.

Sum advanced out of consolidated fund-\$4,481.01.

Total cost of transport, and pay for two days, which is the amount to be repaid by the municipality under the above arrangement, \$2,040.24.
