The duties of Mrs. F. C. Davidson involve the making of actuarial calculations under individual contracts with respect to new or changing contracts, assisting in year-end valuation, the preparation of annual reports, financial statements and carrying on statistical and mortality investigations; assisting with actuarial calculations involving the cost of both past and future service respecting proposed retirement annuity plans for employees; assisting with the annual valuations of retirement annuity plans in force; actuarial calculations concerning withdrawals, deaths and retirements under group contracts.

SELECTIVE SERVICE ADVISORY BOARDS—
E. N. GRIGGS

Mr. KNOWLES:

- 1. Is there a set of employment and selective service advisory boards, national, regional and local, in operation on a voluntary basis? If so, when were these boards established?
- 2. Has there been established recently another set of selective service advisory boards on a salary basis? If so, under what date and by what authority?
- 3. In what way do the functions of the boards referred to in question (2) differ from those of boards referred to in question (1)?
- 4. What position does Mr. E. N. Griggs occupy in the government service? What salary is he paid by the government?
- 5. How many selective service regional advisory directors have been appointed, and what are their salaries?

Mr. MARTIN:

1. There are national and regional selective service advisory boards, also national, regional and local employment committees, all on a voluntary basis.

The national selective service advisory board was established by P.C.-2254, March 21, 1942.

The regional selective service advisory boards were established by P.C. 512, January 28, 1944.

The national employment committee was established September 23, 1941.

Five regional committees have been established by the unemployment insurance commission throughout the dominion.

Local employment committees, of which there are now forty-five, are established whenever the regional committee recommends their establishment or the local employment situation indicates that they are necessary.

- 4. Mr. E. N. Griggs is regional director, national selective service, prairie region. His salary is \$1,800 per annum.
- 5. Four regional directors, national selective service, have been appointed. Their salaries are as follows: Pacific regional director, \$4,500 per annum; Prairie regional director, \$1,800 per annum; Ontario regional director, \$4,800 per annum; Quebec regional director, \$4,800 per annum.
