CLOSING OF TORONTO PLANT BECAUSE OF AUTOMOBILE AGREEMENT

On the orders of the day:

Mr. T. C. Douglas (Burnaby-Coquitlam): Mr. Speaker, may I direct a question to the Minister of Industry. Has his attention been drawn to the fact that the Perfect Circle Company of Don Mills, Toronto, yesterday informed all its employees that the plant would be closed next Friday night as a result of the Canada-United States auto agreement? Since this is only five days' notice affecting 130 employees, more than half of whom have over ten years' service with the company, may I ask whether the minister has been notified by this company of its intention to close its operation and move its machinery to St. Thomas and whether the government is taking any action with respect to the future employment of the employees in question?

Hon. C. M. Drury (Minister of Industry): Mr. Speaker, I was not aware of the plans of the Perfect Circle Company but I would be glad to look into this matter.

Mr. Douglas: Has the minister asked the companies who are likely to be affected by the Canada-United States agreement to give his department and the department of manpower as well as the employees concerned much more adequate notice than five days?

Mr. Drury: Some time ago the Department of Labour issued an invitation or a request to companies involved in the transitional scheme under the automotive pact to notify that ministry of future plans involving changes affecting employees. This representation, or this invitation, was repeated by the department of manpower when it came into the picture, and it is still outstanding. I do not know whether there have been representations made with respect to the precise number of days notice to be given. I think this question is governed by provincial law.

Mr. Douglas: Will the minister undertake to find out whether this company has given notice of its plans either to the Department of Labour or to the department of manpower?

Mr. Drury: I said I would do that, Mr. Speaker.
