# CODE OF ETHICS IN ADVERTISING

On the orders of the day:

Hon. Judy V. LaMarsh (Secretary of State): May I take this opportunity to reply to a question put to me a few days ago by the hon. member for Cape Breton South (Mr. MacInnis) who asked me whether the Canadian Broadcasting Corporation had an advertising code of ethics and, if so, how this code was applied.

On checking with the corporation, I am informed that the C.B.C. has what is known as its commercial acceptance policy designed to ensure that C.B.C. stations do not carry commercial messages which might be considered in bad taste, misleading, deceptive or unfair in their competitive claims. Advertisers seeking to purchase time on C.B.C. affiliates are aware of the corporation's policy and it is also enforced through the C.B.C.'s own commercial sales department.

### EARL CAMERON-USE OF COMMENTARIES IN NEWSCASTING

On the orders of the day:

Hon. Judy V. LaMarsh (Secretary of State): Perhaps I could take this opportunity to reply to a question raised several days ago by the Leader of the Opposition who asked me if I would get a report from the Canadian Broadcasting Corporation in regard to changes which the C.B.C. proposes to make in its national T.V. news.

I now am informed by the corporation that the replacement of Mr. Earl Cameron as announcer on the national news should not be regarded as a demotion for Mr. Cameron, who is being reassigned to new duties. Nor does it represent any change in the basic C.B.C. policy to present the news factually and without bias or distortion.

The corporation made these changes on grounds that its news service must keep pace with the times, and should at this juncture adopt the T.V. news system of employing an experienced professional journalist rather than announcer to present the news, as is done on most other major networks.

## "COLUMBIA RIVER"-CORRECTION IN NAME OF AUTHOR OF DOCUMENTARY

The Canadian Broadcasting Corporation now informs me that, on further investigation, they find this answer is in error and that the original manuscript was written by Mr. Tom Connachie. Mr. Marsh subsequently was engaged to develop this outline into a shooting script and Mr. Connachie then wrote the final script narration.

I should like to set the record straight, and apologize to the house and to the individuals concerned.
