ALLEGED INCONVENIENCE IN SALE OF STAMPS

Mr. Robert Simpson (Churchill): I have a supplementary question for the Postmaster General. In view of the admitted and obvious embarrassment of postal clerks who are on duty on Saturdays and not able to sell stamps at post offices so that they have to tell people to go to sub post offices miles away to buy stamps, will the Postmaster General reconsider these regulations.

Hon. Eric W. Kierans (Minister of Communications): They do not have to go to sub post offices miles away. The sale of stamps does not take place in regular post offices because if it did they would have to keep a supply of stamps and increase their staff considerably, so that the whole purpose of the exercise would be lost. In fact people can secure stamps from any number of sub post offices in the vicinity.
