**Mr. Stanley Haidasz (Parliamentary Secretary to Minister of National Health and Welfare):** I have been requested by my minister to inform the hon. member that while officials of the Department of National Health and Welfare have secured descriptive material on the New Jersey guaranteed annual income plan and have had some conversations with officials in the United States, no investigation has been carried out to date concerning the plan. Such an investigation would not be warranted at this time because the plan is still in its initial phase and no report has been prepared. Under the circumstances, my minister requests that the hon. member withdraw his motion.

**Mr. Knowles (Winnipeg North Centre):** Mr. Speaker, I shall withdraw it and reword it to meet the point the Parliamentary Secretary has made.
