LEPROSY ACT

PROVISION FOR REPEAL

Hon. Ron Basford (for the Minister of National Health and Welfare) moved that Bill S-7, to repeal the Leprosy Act, be read the second time and referred to the Standing Committee on Health, Welfare and Social Affairs.

Hon. J. A. MacLean (Malpeque): Mr. Speaker, perhaps one of the ministers could take this opportunity to give a brief explanation of the bill.

Hon. Allan J. MacEachen (President of the Privy Council): Mr. Speaker, the purpose of this bill is to repeal the Leprosy Act which has really fallen into dissuetude, and is no longer required on the statute books of Canada.

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, we are happy to agree to the second reading of this bill at this time. We have done quite a good portion of work this Wednesday afternoon. Maybe we could get some other pieces of legislation through also.

Mr. Béchard: Old age pensions?

Mr. Knowles (Winnipeg North Centre): That is right. Maybe we could pass my amendment to retain the escalation clause with respect to the basic old age pension. However, I rose simply to say it is interesting to note that we have made sufficient progress in the field of health in Canada, so far as leprosy is concerned, that we do not need this legislation any more. It cannot be said that leprosy has been eradicated so far as the world scene is concerned, and I hope we will continue to make our contribution to the World Health Organization, and in other ways, towards needed improvement in health standards around the world. Meantime, it is good to note this forward step, and we are happy to agree to second reading of the bill.
