However, it would take too long to explain in detail the CFDC's policy in this regard. Briefly, the policy consists in requiring, in order that a company may obtain a loan or other assistance from the Canadian Film Development Corporation, that a certain number of conditions be fulfilled so that the film may be 50 per cent Canadian at the least. But a simple answer to the question whether it is the CFDC's policy to finance foreign film companies would be no.
