Number of persons who started and completed training: (i) under the Training-in-Industry element: (a) 10 persons started, (b) 10 persons completed; (ii) under the Training on-the-job element: (a) 39 persons started training under the 1972-73 contracts and 30 under the 1973-74 contracts, (b) 27 persons completed training under the 1972-73 contracts and 10 under the 1973-74 contracts (the remainder are still in training)
