Out of the \$1.66 charge on a gallon of gas in Ontario, the Alberta government gets 22.7 cents, the Ontario government gets 25 cents, the federal government gets 56 cents, or 33.7 per cent of the amount being charged; the producer gets 19.3 cents, the refiner 33 cents, and the dealer 10 cents. It is obvious the Prime Minister is somewhat misleading in his figures. Under Standing Order 43 I move, seconded by the hon. member for Cambridge (Mr. Speyer):

That the Prime Minister of Canada refrain from giving false information to the Canadian people, designed to pit the east against the west so he can continue to hold power for his own selfish means.
