## **PRIVILEGE**

ALLEGATION BY SENIOR PUBLIC SERVANT—REISMAN—MR. SPEAKER'S RULING

Mr. Speaker: I should like to deliver a brief ruling. On October 30, 1987, the Hon. Member for Kamloops—Shuswap (Mr. Riis) rose to express his view that his privilege as a Member of Parliament had been breached when Canada's Ambassador and Chief Negotiator for Trade with the United States was reported to have likened opponents to free trade to Nazis. The Hon. Member for Windsor West (Mr. Gray) also found offence in the report of Ambassador Reisman's remarks.

The Chair has had an opportunity to review the matter and must point out to the House that, as stated at the time by the Hon. Minister of State (Mr. Lewis), comments made outside the House are not likely to prevent Members from doing their jobs properly, which as Hon. Members know is the essence of privilege.

It is very important, again to the public who are watching and listening, to indicate that something can be inflammatory, can be disagreeable, and can even be offensive, but it may not be a question of privilege unless the comment actually impinges upon the ability of Members of Parliament to do their job properly.

Without belabouring the point, I would refer Hon. Members briefly to a decision by Mr. Speaker Lamoureux on April 29, 1971, when he said in part:

In my view, parliamentary privilege does not go much beyond the right of free speech in the House of Commons and the right of a member to discharge his duties in the House as a member of the House of Commons.

Hon. Members will understand, of course, that the position taken by the Chair in no way condones the sort of language attributed to Ambassador Reisman. However his remarks, whatever they may have been, remain beyond the scope of the privileges of this House.
