REQUEST FOR FREEZE ON HARBOURFRONT CONSTRUCTION PENDING REVIEW

Mr. Alan Redway (York East): Mr. Speaker, at long last I have the honour to present to the House a petition that has been signed by approximately 150 residents of the Harbourfront residential community in Toronto which acknowledges that there is presently a review of the Harbourfront plans for development.

The petitioners indicate their concern with the height, the density, the recreation space and the parking requirements. They also indicate that, notwithstanding the review that is ongoing, buildings are still being constructed without building permits. They call upon Parliament to freeze all of the construction in the Harbourfront area including, in particular, the buildings at 633 Lakeshore Boulevard West, 650 Queen's Quay West and 11 Stadium Road pending the outcome of the review. They also ask that they be allowed input into the review process.

OPPOSITION TO PROPOSED CHANGES TO UNEMPLOYMENT INSURANCE BENEFITS

Mr. Les Benjamin (Regina West): Mr. Speaker, I have the duty and honour to present petitions on three different subjects. The first is from Canadians living in a number of locations in British Columbia.
