GOODS AND SERVICES TAX

Ms. Ethel Blondin (Western Arctic): Madam Speaker, pursuant to Standing Order 36, I rise to present petitions in the House on behalf of my constituents of the Western Arctic.

One of these petitions is on the effect that the goods and services tax will have on skating. The petitioners consider instruction in skating to be an educational service and, therefore, ask the government to exempt skating educational expenses from the proposed goods and services tax.

This petition is from the community of Fort Simpson in the Northwest Territories.

I have a number of other petitions in which the petitioners say that they feel that the goods and services tax will have an onerous burden on the cost of transportation. It will result in a cascading tax because there is already a fuel tax and a transportation tax of 10 per cent.

VIA RAIL

Mr. Jack Whittaker (Okanagan—Similkameen—Merritt): Madam Speaker, I have a number of petitions so I will not go into each one of them individually.

The first one contains the signatures of 177 people who are calling on Parliament to maintain the existing VIA network, upgrade VIA equipment, guarantee VIA sufficiency, and support and carry out its mandate to provide passenger service.

GOODS AND SERVICES TAX

Mr. Jack Whittaker (Okanagan – Similkameen – Merritt): Madam Speaker, the second petition contains a further 606 names of people who, even though third reading of the bill on the goods and services tax is passed, are still indicating their disagreement with it.

They are asking the government to cease with the proposal that shifts the tax burden on to ordinary Canadians through a regressive consumption tax rather than introducing real tax reform.
