That is where we are. As a matter of fact, the last budget that the Peterson government brought down before they were defeated projected a surplus of \$400 million. By the time poor Floyd got the key to the treasury, that had worked its way to a \$700 million deficit.

What happened? This gang—I hate to say this to my left, but that is only figuratively—this cruel, heartless, soul-less gang took actions which created the problems that are now being experienced particularly in Ontario.

In fact, Ontario was the goose that laid the golden eggs for years for this government. It lived off the avails of Ontario. I say it should be charged with pimping. It has lived off the avails of Ontario, and now Ontario has a rough time, they are all deserting the house. They are all leaving the House, and turning around and saying: "It is your fault. You are spending too much".

I want to tell you that the NDP government in Ontario is not prepared to back away from its responsibility to make sure that the victims of this cruel, heartless government do not end up on the street. That is what we say.

CONTRAVENTIONS ACT

MEASURE TO ENACT

Hon. Monique Landry (for the Minister of Justice) moved that Bill C-46, an act respecting contraventions of federal enactments, be read the second time and referred to Legislative Committee H.

Mr. Stan Darling (Parry Sound-Muskoka): Mr. Speaker, I am honoured to rise in the House today and lend support to the Minister of Justice who has set forward her proposals for a federal ticketing scheme.

The Contraventions Act is but one means whereby the federal government can assist provincial jurisdictions in coping with the heavy burden on the courts. The Contraventions Act provides for a ticketing scheme that will be simple and will assist in making the justice system more efficient.

To begin with, the 12 participating departments and agencies have identified almost 4,000 existing minor regulatory offences which will be included in a schedule of offences. The schedule which accompanies the act can be regularly updated and amended so as to meet the future needs of government departments and agencies.

What kind of offences are contemplated by this Contraventions Act? We are talking about minor offences. For example, recklessly driving a motor boat close to shore, hunting without a valid licence, camping in a park without a permit, illegal parking on federal lands.
