Mrs. Darcus, with relatives, left for Victoria to reside late in the summer. Private Darcus was with the machine gun section, of the 26th, one of the originals.

NINE BRITISH AIRPLANES

WOMAN'S \$150 DRESS IS RULED A LUXURY

Husband Earning \$225 a Month Not Liable to Pay Wife's Bill—Judge Archer's Dictum.

(Montreal Gazette.)

"Dresses at \$150 and \$135 each, for a wife whose husband earns \$225 a month are to be considered as luxuries." Under this dictum, expressed by Mr. Justice Archer in the Court of Review Friday, Mr. R. C. Colt succeeded in his appeal from a judgment of the Superior Court, which had condemned him to pay to Dame Rebecca Jacobs the sum of \$386.25 for goods supplied to Mrs. Colt.

"If the plaintiff is to lose the amount claimed," added Justice Archer, "it is due to her own negligence in not ascertaining the exact position of her client."

The account which formed the basis of the claim was composed of the following items:

March 30, 1916, 2 imported tulle and net dresses, \$150.00
March 31, tan suit, 135.00
One veil, 1.25

Total \$386.25

"It appears by the evidence," said Mr. Justice Archer, "that defendant (Mr. Colt) and his wife were not living together. Defendant left his wife, and she took an action in separation from him and got judgment in her favor ordering the separation, and defendant was condemned to pay her \$30 a month for her clothing and sometimes he would allow her to get some extras."

The Governing Law.

"We have not here to discuss the position of the parties as if separated as to property. Though they were married in England, there is no proof of the law of England, and we are governed by the laws of this province, where the community of property exists, unless there is a special marriage contract. Article 175 of our Civil Code says: 'A wife is obliged to live with her husband and follow him wherever he thinks fit to reside. The husband is obliged to receive her and to supply her with all the necessities of life according to his means and condition.'"

"Article 1280 says: 'The liabilities of the community consist of the debts, whether of capital sums, arrears or interest, contracted by the husband during the community or by the wife with the consent of the husband, saving compensation where it is due.'"

"The tacit mandate which the wife may have under Article 1280 of the Civil Code is, in my opinion, limited. The dresses in question were sold to defendant's wife and charged to her personally. It is evident plaintiff did not intend giving credit to the defendant, but to his wife. As there was community of property, plaintiff took the present action against defendant who pleaded that he never authorized his wife to buy the goods in question, and that the same were unnecessary under the circumstances; that he never received any benefit or value from the transaction which was, he submitted, wholly illegal and void.

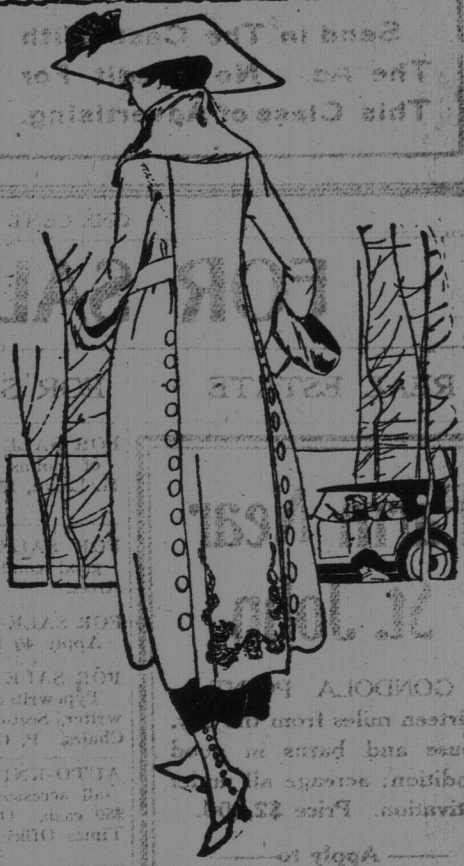

Must Get More

Reports at Victoria Local headquarters last night showed that the province, St. John county not included, has to date subscribed \$7,022,750.
