**C.O.'S COMMENDATIONS** On February 24, 1983, Cst. McDonald who was off duty but in the Morinville RCMP office doing some paper work, responded to a call for assistance by other detachment members. Cst. McDonald went to Highway 28 near Morinville to assist in directing traffic and keeping the crowd away from an overturned propane truck which was on fire and leaking propane from its tank. Upon arriving at the scene Cst. McDonald was directed to stop a busload of people on the Greyhound bus and keep them back. The propane tank had been heated to such an intensity, it had become what is known as a blevy and it was obvious it would explode. Cst. McDonald directed people away from the scene, thereby placing himself in considerable danger. When the blevy blew, he was knocked into the ditch and suffered minor scrapes and abrasions but was successful in removing a large number of civilians from the scene who would have been injured or perhaps killed. On May 10, 1985, Cst. McDonald received the Commanding Officer's Commendation for: "noticeable and above-average dedication and courage under dangerous conditions on the 24th day of February, 1983, near Morinville, Alberta, while not officially on duty, and at the sacrifice of his own safety, [did] direct bystanders away from the scene of an explosive fire, minimizing personal injury to the public."
