Return to an Address of the Legislative Assembly, dated 18th July, 1866; for information respecting certain operations of *Montreal Harbour Commissioners*. (*Sessional Papers*, No. 50.)

On motion Mr. *Morrison*, seconded by Mr. *O'Halloran*,

Ordered, That the Bill from the Legislative Council, intituled, "An Act to enable "*Hugh Burgess* to obtain a Patent for certain new and useful improvements," be now read the first time.

The Bill was accordingly read the first time; and ordered to be read a second time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to vest the Protestant Burial Ground at *Hudson* in the Incumbent and Church wardens of *St. James' Church, Vaudreuil*; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Knight* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Ordered, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to authorize the issue to Messrs. *J. D. Whelpley* and *J. J. Storrer* of Letters Patent for a new and improved system of treating metallic ores; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Jones* (South *Leeds*) reported, That the Committee had gone through the Bill, and made amendments thereunto.

Ordered, That the Report be now received.

Mr. *Jones* (South *Leeds*) reported the Bill accordingly; and the amendments were read and agreed to.

Ordered, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to incorporate the *Crystal Lake Cemetery Company*; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Irvine* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Ordered, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to enable *John Auld* to sell certain Real Estate; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Jackson* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Ordered, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to remove doubts as to the legality of a Canon of the Synod of the Diocese of *Quebec*, respecting the Parish and Chapels of *Quebec*; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Ault* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Ordered, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to erect the County of *Peel* into a separate County, for judicial purposes; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *White* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Ordered, That the Bill be now read the third time.

The Bill was accordingly read the third time.

Resolved, That the Bill do pass, and the title be, "An Act to complete the separation "of the County of *Peel* from the County of *York*."
