*To His Excellency Dominick Daly, Esquire, Lieutenant Governor and Commander-in-Chief in and over Her Majesty's Island Prince Edward and the Territories thereunto belonging, Chancellor, Vice Admiral and Ordinary of the same, &c. &c. &c.*

MAY IT PLEASE YOUR EXCELLENCY :

The House of Assembly respectfully acquaint your Excellency, that they have adopted a Report of the Committee of Supply, whereby they have resolved to place at the disposal of the Executive Government, a sum sufficient to provide for the maintenance of such constabulary or other force as the Lieutenant Governor in Council may think advisable to call into requisition, in the absence of Her Majesty's Troops,

should the same be required, to maintain the supremacy of the Laws, and to preserve internal tranquility; also, a sum sufficient for the exigencies of the public service, until the end of the present Session, which is to include the contingent expenses of the Legislature, the casual repairs of Roads, Bridges and Wharfs, until the usual annual appropriation is made for that service, and likewise, a sum not exceeding One hundred pounds for the immediate and necessary repairs in and about the Government House. The House respectfully request that your Excellency will be pleased to give effect to their intentions, as hereinbefore expressed and provided for.

*Ordered*, That the said Address be engrossed.

*Ordered*, That the same Committee who prepared the Address, be a Committee to wait on His Excellency with the same.

Then the House adjourned until to-morrow at Ten o'clock.
