City Solicitor's Opinion Leaves Annexed Territory Without Definite Status.

MIX-UP OVER CITY COUNCIL CAUSES MIRTH

Know What It Was Doing, if City Solicitor Is Right.

The statement of City Solicitor Meredith regarding the number of aldercil is the topic of conversation about all of the 55 railways east of the Missisthe city hall today, and there is a wide sippi River in Canada and the United States on Jan. 27, divergence of opinion on the question. In conversation with a number of local lawyers today the opinion was expressed that Mr. Meredith was wrong in his judgment and that the city was named entitled to have fifteen aldermen. Other

lawyers sided with the solicitor. The city solicitor's opinion places the Ontario municipal and railway board in an unenviable light. The board unanimously decreed that there were five wards in the city. The municipal act distinctly states that the representation in the council shall sequently, the council should consist of fifteen members.

City Solicitor Meredith in his opinion declares that the Ontario railway and municipal board had not authority to add a fifth ward, and consequently there is no fifth ward.

A Question.

The question naturally arises: What ward does the annexed district form The Ontario railway and municipal board did not add the new territory to the wards now in existence. There are no boundary lines defined. The whole question, if Mr. Meredith's opinion is accepted, is left in a most chaotic con-

Another question propounded those interested relates to the position of the electors in these new divisions. If they are not entitled to vote as citizens of w rd 5, are they entitled to vote at all? The Ontario board says they belong to ward 5, and as such are entitled to vote. City Solicitor Meredith says there is no ward 5, but that the electors are entitled to vote. It is rather an interesting situation, and it is occasioning a great deal of

talk about the streets. If the Ontario board did not know its powers, the situation is a ludicrous one, and is another evidence of the incompetency of that organization, which has become the joke of the province.

Fifteen Aldermen.

As already stated, some of the city's leading lawyers say the city is entitled to fifteen members, and that a good case could be made if any person took sufficould be made it any person took suffi-cient interest in the matter to take it to the courts. The legality of the whole election could be taken into court, it is claimed, and all the aldermen unseated. At the present time it does not seem likely that any person will take this action and no one can say the present action, and no one can say the present aldermen are at fault.

"In my judgment the whole election was most irregular," declared one of the was most irregular, declared one of the leading barristers of the city today. "The Ontario Railway and Municipal board plainly ordered the new territory annexed, to be known as Ward 5. This added three members to the council. This added three members to the council.
