New York, Sept. 14.—The Board of Health announced this morning that a bacteriological examination made by Prof. Herman Biggs on the bodies of several suspected cholera patients here have been five deaths from Asiatic cholera in the City of New York.

The first witness was Louis Lafere, one of the victims of the shooting affray, who appeared with a wounded arm hanging in a sling. His evidence was given in a straightforward manner and had great weight with the jury.

The jury retired at 7 p.m., and were only out about 15 minutes when they returned with a verdict of "Guilty of willful murder." The prisoner was very composed when the verdict was brought in.
