If there is anything in the hon. gentleman's motion which was not called for in the motion of the hon. member for Selkirk, that would be produced separately.

Some hon. Members: Agreed.

Mr. Speaker: Do I understand that the same reservation would apply to the other motion?

Mr. Pickersgill: I think the motion is acceptable as it is.

Mr. Speaker: My question is, does it apply to the subsequent motion standing in the name of the same hon member?

Mr. Pickersgill: I think the subsequent motion stands on its own feet.
