## REGULATIONS RESPECTING SALES TAX INCREASES

On the orders of the day:

**Mr. H. A. Olson (Medicine Hat):** Mr. Speaker, I should like to direct a question to the Minister of Finance. Has the minister published or given wide publicity to the regulations respecting the application of the sales tax increments during the various stages, as he promised to do earlier this session? This matter is becoming urgent, as construction tenders now being called will be affected by the future application of these regulations.

**Hon. Walter L. Gordon (Minister of Finance):** Mr. Speaker, I thank the hon. member for sending me notice of this question which, strictly speaking, falls within the purview of the Minister of National Revenue. However, I am pleased to advise him that the Department of National Revenue has given wide distribution to the amendments to the Excise Tax Act, explanatory bulletins and circulars. These have been distributed to known or potential licences, to interested associations and to individuals concerned, and have been advertised and made available in all customs and excise ports, district excise tax audit and excise tax collection offices throughout Canada.

## NORRIS COMMISSION—ANNOUNCEMENT OF CHARGE LAID AGAINST HAL BANKS

On the orders of the day:

**Hon. Michael Starr (Ontario):** Mr. Speaker, I should like to direct a question to the Minister of Justice. Has he anything to report to the house with regard to the report of the special counsel retained by him to look into the Norris commission evidence, and is he now prepared to take the house into his confidence with regard to whether the report of counsel states that there is evidence justifying the laying of charges?

**Hon. Lionel Chevrier (Minister of Justice):** Yes, Mr. Speaker, I have an answer to the hon. gentleman's question. Upon the advice of special counsel appointed to consider the evidence in connection with the Norris report, a charge has been laid against Hal Banks in Montreal for conspiring to commit an assault occasioning bodily harm upon Captain Walsh. Mr. Jean Martineau, Q.C., special counsel, will prosecute.

Counsel are considering other charges against the president and certain other officers of the S.I.U. arising out of the Norris report and the recent illegal strike. The charge already laid against Mr. Banks and referred to above will be pressed forward in conjunction with these other charges when counsel have come to a conclusion in regard to them and the necessary preparations have been completed.
