#### Questions

5. No funds have been allocated specifically for the use of these supervisors. Postmasters have authority to approve the use of privately owned motor vehicles by all supervisory officers who might be required to do so in the performance of their duties where no public transportation is available or convenient. Such expenses will be paid out of a general travel fund.

### POSTAL RATES REQUIRED TO MAINTAIN RATIOS

## Question No. 1,787-Mr. Kaplan:

Has the Post Office Department estimated what postal rates must be set to maintain the present ratios as between classes of mail service and provide six-day service without additional deficits and, if so, what are such rates?

Hon. Eric W. Kierans (Minister of Communications): In so far as the Post Office Department is concerned: The saving in cost in reducing to 5-day delivery service in urban areas is approximately \$10,000,000 annually. While it would be difficult to estimate the effect on all postal rates of restoring this service, it would be necessary to increase the letter rate by the equivalent of  $\frac{1}{2}c$  a letter to offset the cost of the additional delivery service.

## PRE-DOCTORAL CANADA COUNCIL GRANTS

### Question No. 1,926-Mr. Saltsman:

- 1. In the academic years 1965-66, 1966-67, 1967-68, 1968-69, 1969-70, how many applications for predoctoral Canada Council grants were received?
- 2. In those years, how many were granted? 3. In those years, how many were turned down for lack of funds rather than lack of merit?

Hon. Gérard Pelletier (Secretary of State): I am informed by the Canada Council as follows: 1. The numbers of applications for pre-doctoral fellowships were as follows: in 1965-66, 931; in 1966-67, 1053; in 1967-68, 1,435; in 1968-69, 2,504; in 1969-70, 3,603. It should be noted that the figure for 1965-66 includes 168 applications under the pre-master scholarship program which was discontinued that year.

- 2. The numbers of pre-doctoral fellowships granted were as follows: in 1965-66, 323; in 1966-67, 429; in 1967-68, 949; in 1968-69. 1,554; in 1969-70, 2,165. The figure for 1965-66 includes 33 awards under the pre-master scholarship program which was discontinued that year.
- 3. Such statistics are not known. The Council in allocating funds for doctoral fellowships takes into account the possible number of applicants from the universe of eligible doctoral candidates and the requirements of its other programmes. The members of the selection juries in assessing the applications rank the candidates in order of merit within a quota system, the formula being that of a competition and not of an examination. It is not possible, therefore, to determine the number of deserving candidates not being offered awards in a given year for lack of funds.
