Mr. Woolliams: When the minister is having this situation investigated, would he be prepared to send government experts into the area to examine this problem with the idea of using the experience that may result from this destructive leakage in the pipeline and its effect on the ecology in the north?

Mr. Greene: Mr. Speaker, I would be glad to consider that suggestion.
