#### OVERFISHING OF SALMON OFF GREENLAND BY DANES— GOVERNMENT ACTION

Mr. Tom Bell (Saint John-Lancaster): Mr. Speaker, I have a question for the Minister of Fisheries, though I would not want to interfere with the Prime Minister any time he wishes to leak part of the budget. Does the government have evidence of overfishing of salmon by the Danes off Greenland in open defiance of the salmon agreement in which the minister took great satisfaction? If this is so, what is the hon. gentleman's next move to be? Where does this leave the Atlantic salmon fishermen and the ban that was imposed?

Hon. Jack Davis (Minister of Fisheries): As to evidence, the answer is yes, we have evidence of overfishing. As to what we are going to do next, the Internationl Commission for the North Atlantic Fishery meets in June and we shall be dealing with the salmon issue at that time.
