DEPARTMENT OF MANPOWER AND IMMIGRATION— OVERTIME PAY

Question No. 1,963-Mr. Andre:

During the months of January, February and March 1973, respectively, what were the total amounts paid in overtime pay to employees of the Department of Manpower and Immigration?

Mr. Mark MacGuigan (Parliamentary Secretary to Minister of Manpower and Immigration): January 1973, \$322,627.13; February 1973, \$290,351.07; March 1973, \$329,967.46.

IMPORTS FROM SOUTH AFRICA

Question No. 2,010-Mr. Diefenbaker:

1. What was the total value of imports into Canada from South Africa (a) January 1, 1972 to December 31, 1972 (b) January 1, 1973 to April 1, 1973?

2. Of such amounts in said periods, what was the value of imports of South African grapes?

Mr. Herb Breau (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Statistics Canada reports that: 1. (a) The total value of imports into Canada from South Africa in the calendar year 1972 amounted to \$58,942,000; (b) in the first quarter of 1973 total imports from South Africa amounted to \$7,775,000.

2. Imports of grapes from South Africa into Canada in the calendar year 1972 amounted to 2,969,770 pounds for a value of \$605,000. In the first quarter of 1973, these imports totalled 302,100 pounds valued at \$70,000.

GRANT TO WRITE HISTORY OF JAPANESE CANADIANS

Question No. 2,042-Mr. Saltsman:

1. What were the names of the individuals or the group of individuals who applied for the grant to the Department of the Secretary of State in order to write up the history of the Japanese Canadians?

2. What was the amount in dollars of the grant these individuals or group of individuals wanted to get out of the governmental fund?

5. If no one did, is it possible to submit another proposal for consideration and, if not, for what reasons is the history of the Japanese Canadians to be omitted from the series of Ethnic Histories?

Hon. Stanley Haidasz (Minister of State): 1. Three applications were received: (a) Ken Adachi, Toronto; (b) Dr. John Howes, University of British Columbia, Margaret Prang, University of British Columbia, Mitsuru Shimpo, University of Waterloo; (c) James Frideres, University of Calgary.

2. (a) \$7,500; (b) \$26,459; (c) \$9,745.

3. The academic panel which judged the applications received a submission from Mr. Adachi who has been working on a history of Japanese Canadians for a number of years with the support of the Japanese Canadian Citizens' Association. About half the manuscript, 400 pages, has been completed and the academic panel judged it to be of high quality. The panel decided that a project grant should be given to complete this work although it would be too large to be incorporated in the series. The other two applications were rejected because it was felt that it would be better to help complete a project which was well under way than to initiate a totally new, and competing project.

4. The amount and the conditions of the grant are presently being negotiated with the JCCA and Mr. Adachi.
