# CANADA'S PARTICIPATION IN PROGRAM—MOTION UNDER S.O. 43

**Mr. James A. McGrath (St. John's East):** Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. The year 1979 has been designated by the United Nations as the International Year of the Child, a fact which has been virtually ignored by this government whereas 70 other countries have set up commissions for this very purpose. This marks the twentieth anniversary of the declaration of the rights of children by the United Nations, to which Canada was a signatory. I, therefore, move, seconded by the hon. member for Edmonton-Strathcona (Mr. Roche):

That this House directs the Minister of National Health and Welfare to make a statement in this House before the adjournment on Canada's intentions with respect to the International Year of the Child and what plans, if any, the government has under way to participate with the provinces in recognizing and implementing the principles embodied in the United Nations' declaration.

**Mr. Speaker:** The presentation of such a motion for debate, pursuant to Standing Order 43, can be done only with unanimous consent. Is there unanimous consent?

### FEDERAL-PROVINCIAL RELATIONS

QUEBEC GRANT TO ALLEGED COMMUNIST-FRONT ORGANIZATION—MOTION UNDER S.O. 43

**Mr. Tom Cossitt (Leeds):** Mr. Speaker, I rise on a matter of urgency. If all hon. members will listen carefully, I think they will agree that this motion deserves the support of both sides of the House. It is in relation to a grant in the amount of \$51,000 being given by the province of Quebec under the authority of Claude Morin, provincial minister of intergovernmental affairs, to an organization calling itself The Preparatory Committee of Canada for the Eleventh World Festival of Youth and Students, Box 99, Station V, Toronto. The festival is to be held in Havana, Cuba, July 28 to August 5, and the agenda proclaims in newsletter No. 5 the slogan "Anti-imperialist solidarity, peace and friendship" and announces youth delegates will be told methods of carrying out profound "political transformations" in their home countries. I, therefore, move, seconded by the hon. member for Hastings (Mr. Ellis):

That this House registers its disapproval of such a reprehensible grant by the government of Quebec to an apparent communist-front organization, and strongly urges the Quebec government to cancel immediately any portion of the grant not yet paid and, finally, requests the Premier of Quebec to order an end to any Quebec support—
