NORTHWEST TELEPHONE—CALL TO MEET REQUIREMENTS OF LICENCE—MOTION UNDER S.O. 43

It is supplying telephone service for a large area of northeastern British Columbia adjacent to the Alaska highway. The company is charging individual Canadians a \$680 fee for a simple hook-up and is not in a position even to provide such service. I therefore move, seconded by the hon. member for Fraser Valley East (Mr. Patterson):

That for reasons of total neglect and failure to provide even the most basic service dictated by the licence under which Northwest Telephone operates in northeastern British Columbia, the company be given six months from this day to implement a service which not only fulfils the requirement of the licence but is consistent with the company's widely advertised policy whereby their service to the public is not only a business but a responsibility; and that failing the company's compliance with this requirement, the licence will be revoked.
